1. 參加者要負責明白自己的身體狀況及健康是否適合是次活動。
Applicants make sure that he/she is physically fit and suitable to participate in such event.
2. 報名一經接納，不得轉讓名額，退出者所繳付之費用或部份概不退還。
Applicants will not be allowed to change their entry to others or to refund their entry fee or part thereof when their application is submitted.
3. 本會建議參加者自行安排保險之事宜。本會不會負責任何意外及其它損失或賠償。
The Council suggests that applicants must have their own insurance covers. The Council shall not be responsible for any loss or injury to any applicant or third party in such event.
