條 款 Terms and Conditions

- 1. 参加者要確保自己的身體狀況適合是次活動。

Event In-charges shall decide whether or not an event will proceed if Typhoon Signal no.3 or below is hoisted or Yellow/Red Rainstorm or Storm Warning is issued <u>two</u> hours before the event begins. Applicant should attend the event as scheduled if no notification is received.
