條 款 Terms and Conditions

- 1. 参加者要確保自己的身體狀況適合是次活動。
 - Applicant makes sure that he/she is physically suitable to participate in such event.

 - Applicant will not be allowed to change his/her entry to others or get refund of his/her entry fee once the application has been accepted. (Please enclose a stamped envelope for an official receipt.)

- 4. 本會有權決定接受或拒絕任何申請,而不須作任何解釋。
 - The Council reserves its rights to accept or reject any application without giving any explanation(s).
- 5. 参加者於活動舉行期間,須絕對服從活動負責人或工作人員之指示,如有任何不適,須立即向有關工作人員尋求協助。
 - Applicant must follow all instructions and agree to all decisions of the Event In-Charges or Officials during the event, and inform them immediately in case of sickness.
- 6. 活動負責人及本會職員有權拒絕不守紀律的參加者繼續參與活動,所繳之費用或餘下課堂之費用概不 發還。 本會亦有拒絕任何參加者參與活動的最終權利,而不需要提供任何理由。
 - Event In-Charges or Officials reserve the rights to refuse the applicant to continue an event due to disciplinary issues, and his/her entry fee or any part thereof will not be refunded. The Council reserves its rights to refuse any applicant to attend the event without giving any explanation(s).
- 7. 當天文台懸掛八號或以上颱風訊號或黑色暴雨警告訊號,是次活動將自動取消。
 - The event will be cancelled if Typhoon Signal no.8 or above is hoisted and/or Black Rainstorm Warning Signal is issued.
- 8. 若活動集合前二小時,天文台懸掛雷暴或雷雨警告訊號、黃色暴雨戒備訊號、紅色暴雨警告訊號、三號或以下颱風訊號,是次活動將依天氣情況,由活動負責人決定該活動是否繼續進行,如收不到任何通知,參加者需依照原定時間、地點集合。
 - Event In-charges shall decide whether or not an event will proceed if Typhoon Signal no.3 or below is hoisted or Yellow/Red Rainstorm or Storm Warning is issued <u>two</u> hours before the event begins. Applicant should attend the event as scheduled if no notification is received.
